SCAN THE QR CODE ON YOUR CHARGE POINT BOX OR BELOW


After downloading the app, scan the Monta QR Code on the charge point packaging or this page with your QR scanner.

QR codes scanner located on the maps page on the top right hand side as shown.



OPEN THE APP



Follow the links to open the app.

Where to find it in the App?



Click into the Installer menu, choose charge installations for existing location and select your location. Choose the charging station and the number will be shown.
